### I. Call to Order / Introductions - Randy Parsons, Chair

- a. Randy called the meeting to order at 10:45 am and welcomed all the guests.
- b. Randy introduced new Planning Council member, Mistie Coovert.

### II. Planning Council Minutes

- a. Francine Pratt moved to accept the minutes as presented.
- b. Don Clyburn provided the second.

c. The motion carried unanimously.

### III. Program

- a. DSHS Case Management Standards of Care
  - i. Jamie Schield reviewed with the group the Planning Council's new case management model. He explained how DSHS had been working on case management for Texas for over two years. He noted that the new standards were different from the previous standards and could not be compared side by side.
  - ii. Jamie introduced the panel Paula McNeely (PMC), Stephanie Cagle (AOC), and Francine Pratt. Jamie added that Paula and Francine both sat on the state's case management expert panel.
  - iii. Francine expressed some concern over the new standards. In particular, Francine felt all the requirements for case managers could be time consuming. She added that many of the requirements were standard practice for social workers and case managers.
  - iv. Stephanie Cagle explained that AOC has been preparing for the shift to this new case management system by allowing clients to renew and recertify via mail. Stephanie said that the new standard's philosophy of "not everyone client being in case management" would help case managers spend more time with those clients who truly need case management.
  - v. Paula McNeely agreed with Stephanie. Paula reiterated how many case managers currently have case loads of more than 100 clients. By not requiring every client to be in case management, case managers can have more quality time with those in case management.
  - vi. Several people from the group provided input. Some questions that were asked included, "Who should conduct the intake?" "Are all agencies using the same acuity scale?" "Is there a progressive acuity?" "Is the acuity for the client or for what the agency can provide?"
  - vii. Gil Flores shared with the group that the Positive Voices groups discussed case management in January. Clients expressed there concerns and needs for an initial intake. Clients felt that Patient Navigators (peer advocates) are very important.
  - viii. Gil announced that the Evaluation Committee will begin reviewing the local Standards of Care for Medical Case Management, Non-Medical Case Management, and Patient Navigator at the March Evaluation Committee meeting. All case managers are encouraged to attend and provide input.
